# Overview

This three-day event is being sponsored by United Methodist Advocacy in Pennsylvania and is intended to provide information and inspiration for Christians who believe that the Church has a role in society, including influence on public policy.

This event coincides with our denominational initiative, Change the World Weekend.

Saturday, May 18 will consist of a conference on subjects relating to faith and politics. All three Pennsylvania United Methodist bishops will be speaking. Dr. Jon Brockopp of Penn State University will act as the featured speaker. His topic will be Climate Change and Moral Vision. In addition to plenary gatherings, participants will be able to attend two workshops. Attendance of the Saturday conference requires registration, with a \$30 fee—including lunch. Student registration fee is \$10. Conference registration is open to all. Clergy receive .4 CEUs.

Saturday, May 18 conference location is Paxton United Methodist Church, 3550 N. Progress Ave., Harrisburg, PA 17110.

Sunday, May 19 and Monday, May 20 scheduled activities are free and require no registration—with two exceptions on Sunday as noted in the day's description, below.

# Workshops

## **Four Quadrants of Caring: Rev. Dr. Clayton Childers**

This workshop will consider how we as a church can respond to persons in need in ways that preserve dignity, build mutuality, and support just, long-term solutions. It introduces the concept of identifying four categories of responses in caring for those in need: Charity, Mutuality, Advocacy or Solidarity—all appropriate and needed in particular circumstances. This workshop will affirm political involvement as a way to achieve justice and that working on policy issues and grassroots organizing are ways the church can make a positive witness and contribution.



Clayton Childers, an elder in the South Carolina Conference, serves as Director of Conference Relations at the United Methodist General Board of Church and Society, Washington DC. He and his wife, Denise, live in Manassas, Virginia.

## **The Pennsylvania State Prison System: Rev. Ulli Klemm**

This workshop will cover current developments in the Pennsylvania Department of Corrections. The state's prison system has undergone significant changes over the last six years. Learn about the new initiatives, accomplishments and challenges as Pennsylvania seeks to be a leader in corrections reform. There will be opportunity to ask questions regarding conditions, protocols, and policies.



Rev. Ulli Klemm serves as the Religious Services Administrator for the Pennsylvania Department of Corrections. In this capacity, he monitors, resources and supports the chaplaincy programs in each of the 25 state prisons in Pennsylvania. He visits each of the prisons regularly to ensure they meet Department standards. Recently, he was also given the responsibilities to oversee the Department's Inmate Employment program, Recreational Activities and Volunteer Services. An ordained Mennonite pastor, with credentials through the Mennonite Church USA, Ulli resides in Mechanicsburg, PA with his wife, where they are active members of a Mennonite Church. Together they are the parents of two young adults.

# Workshops

## Justice and Gerrymandering: Dr. Carol Kuniholm

This workshop will explore the questions of what is gerrymandering and why does it matter for faith communities. Learn about the grassroots growth of the legislative redistricting reform movement during the last few years. Carol will provide information about where the movement stands now and what are its immediate goals. Also find out about the inner workings of Harrisburg and how the procedural rules can impede good policy.



Carol Kuniholm is co-founder and chair of Fair Districts PA, a non-partisan, all-volunteer coalition working on redistricting reform in Pennsylvania. She is also Vice President of Government and Social Policy on the state board of the League of Women Voters of Pennsylvania. She received a PhD in American literature from the University of Pennsylvania, taught literature and writing at the college level and served for over a decade as Director of Ministry to Youth and their Families at the Church of the Good Samaritan in Paoli. She and her husband Whitney live in Exton, PA.

## Human Trafficking: Sarah Robinson, Esq.

This workshop will provide an overview of sexual exploitation in human trafficking from a legal perspective. Learn what sex trafficking is, who is involved, and how victims are affected. Sarah Robinson will explain the Pennsylvania state and federal laws related to sex trafficking. She will discuss legislation that is currently pending in the General Assembly that would enhance penalties to hold perpetrators accountable and further provide for protection of women, children, and other potential victims. Ms. Robinson will present data on the status of statewide prosecutions. Participants will learn about the signs and indicators of sex trafficking victims and suggest ways community members can get involved to combat this insidious crime.



Sarah Robinson is the Justice for Victims Fellow for the Villanova Law Institute to Address Commercial Sexual Exploitation. In this position, Ms. Robinson provides trauma-informed legal advocacy to victims and survivors of commercial sexual exploitation. She focuses her practice on post-conviction remedies for sexually exploited people. Ms. Robinson hosts legal intake hours at the Salvation Army's New Day Drop-In Center in Kensington—where she continues to learn about the legal needs and challenges sexually exploited people face in Philadelphia. Outside of direct representation, Ms. Robinson regularly trains attorneys, law enforcement, and other stakeholders on human trafficking laws, contributes to local policy development, and engages in legislative reform advocacy. She is a member of the Pennsylvania Bar.

## How a Bill Becomes Law: Rev. Sandy Strauss

Have you ever wondered about the legislative process in Pennsylvania and how laws are created? This workshop will describe the legislative process from conceptualization to final enactment. It is rarely simple, there are many detours and most bills never make it to completion. Additionally, learn how to find information on the legislature and current legislation. Rev. Strauss will also talk about her role and experience as a faith-based advocate in Harrisburg.

As Director of Advocacy and Ecumenical Outreach, her responsibilities are to inform, educate and empower people of faith on significant public issues, manage communications, and organize Council events. # Workshops

## Politics and Religion Curriculum: Rev. Sandy Strauss

This workshop will introduce a new adult Christian Education curriculum entitled The Role of Religion in Public Life. Receive an overview and participate in a sample lesson. The curriculum was authored by Rev. Strauss, with the input of the Public Witness Commission of the Pennsylvania Council of Churches. This material is a flexible exploration of how Christians can engage as citizens in secular American government. It pulls together the disciplines of theology, Bible, Church history and Civics. This curriculum is suitable for use in Sunday School, Bible study, men's and women's societies, older youth groups, personal study, etc. Participants will receive a hard copy at no cost.

They emphasize the practice of inclusiveness, peacemaking, ecological stewardship and economic justice, among other values. ## Crafting a Moral Vision: Dr. Jon Brockopp

Moral Vision, as defined by philosopher Anthony Weston, is positive, open to all, and expansive. It is an act of imagination that creates the possibility for common action, even on divisive issues like climate change. In this workshop, we will explore the stories of our faith traditions that inspire us, and we will use these as a basis to start building our own sense of a visionary response to climate change. We will also consider ways that we can live out this vision in our homes, places of worship, and beyond.



Jonathan Brockopp is Professor of History and Religious Studies at Penn State University and co-founder of Pennsylvania Interfaith Power & Light (PA IPL), a religious response to climate change. He is the author or editor of several books on early Islamic history, comparative religion, and religious ethics. At Penn State, he has organized two conferences on climate change, developed a course on the Ethics of Climate Change, and given many talks on related topics, including two appearances on local PBS affiliate, WPSU. For each of the past seven years, he organized a bicycle trip with PA IPL, leading dozens of riders from State College to Washington, DC, to speak with the PA congressional delegation on faith and climate change. A member of Grace Lutheran Church, State College, Brockopp has also served on the ELCA advisory council on Lutheran-Muslim relations.

# Day 2: Overview

A tour of the state Capitol building will be offered. The Pennsylvania Capitol building is one of the most beautiful and impressive capitols in the United States. Indeed, its structure contains abundant artwork and iconography. Because of the Commonwealth's Quaker roots, the imagery often has religious overtones. The Capitol contains the legislative member offices, the meeting chambers of the General Assembly, the offices of the Governor and Lieutenant Governor, and a Supreme Court courtroom. Every resident of Pennsylvania should see the Capitol building. Contact Rev. Morgan for arrangements.

The Pennsylvania State Museum is one block away from State Street and the state Capitol. A visit to the State Museum would be a worthwhile activity. However, this option would be on one's own. Admission to the State Museum is \$7, with discounts for seniors, children and veterans.
